# MYSA Structure and Events

The MYSA Board of Directors serves the membership and administrates MYSA programs and services. There are 13 Board Members from across the State, comprising a wide range of experience and opinions.

The MYSA State Office is located in St. Peters, MO and is open Monday – Friday from 9am – 4pm. We have three (3) full time employees dedicated to serving our membership.

The Annual General Meeting (AGM) is held each year to vote on officers and issues. At the AGM ideas and information are exchanged between the MYSA members and the MYSA Board of Directors.

Hearing and Appeal Committee assists with issues of governing and conflict.

MYSA Risk Management services offer a confidential program that is safely accessed online. Each coach, manager, and board member must complete a background check before they can participate.

MYSA Director of Coaching provides training sessions, clinics, camps and more to member players. The DOC Coaches Licensing Courses as well as motivational talks at your local schools.

MYSA's Communication Network. Through its board members and website, MYSA can distribute state and district information quickly. The MYSA website includes many useful aids and tools. <http://www.mysa.org>.

The MYSA College Showcase gives high school boys & girls the opportunity to play soccer in front of college coaches.

The Kohl's Cup is the first in MYSA's 3-tiered state-sponsored competitions, specifically for recreational teams.

Presidents Cup is our second MYSA-sponsored tournament and first for competitive teams.

US Youth Soccer National Championship Series: State Cup is a tournament designed to crown the best of the best in Missouri for the U13-U19 age divisions.

# MYSA Programs and Services

## Coaching Clinics/Coaching Licenses:

Denny Vaninger, MYSA Director of Coaching, will conduct one (1) free 'F' Coaching clinic a year.

Player Training: Denny Vaninger offers free age-appropriate special training sessions upon request.

School Assemblies are conducted by Denny Vaninger to promote soccer registration and incorporate lessons to kids on how to be a good student, leader, and person.

Parent Education: Denny Vaninger offers classes focused around the "We're all in this Together" program.

Summer Camps: MYSA conducts a number of summer camps for all ages and levels each summer.

Got Soccer Online Registration significantly enhances the registration process for MYSA members, allows for easy tracking of players and puts valuable information at your fingertips.

Updated Information is mailed regularly to MYSA members to insure

that all vital information is available to the MYSA membership in a timely manner.

Insurance Coverage: MYSA provides secondary insurance for all players and coaches, insurance to rent facilities, and liability & crime insurance for each member's board of directors.

Sanctioned Tournaments and Events ensure continuity and quality for MYSA members to organize and run their tournaments.

Online eTravel enables teams to easily obtain travel permits for tournaments out-of-state.

MYSA's Olympic Development Program (ODP) identified the top skilled Missouri players and grooms them for possible Regional and National competition.

TOP Soccer is a wonderful program that brings the joy of soccer to players with physical or mental disabilities.

# How to Apply for MYSA Membership

A properly formed league or club with a minimum of 60 registrations and no less than 4 teams is eligible to apply for membership in MYSA. Registrations may include coaches, administrators and trainers.

To apply for membership you must complete an application packet that will include:

- MYSA Membership Application Form (Included in this packet)
- Letter of Intent
- MYSA Membership Form (Included in this packet)
- MYSA Delegate Form (Included in this packet)
- Application fee, \$125 check written to MYSA
- Two certified and correct copies of your Constitution
- Two certified and correct copies of your Bylaws
- Two certified and correct copies of any written Rules or Policies
- Other governing documents appropriate to understanding the structure and activities of the organization.

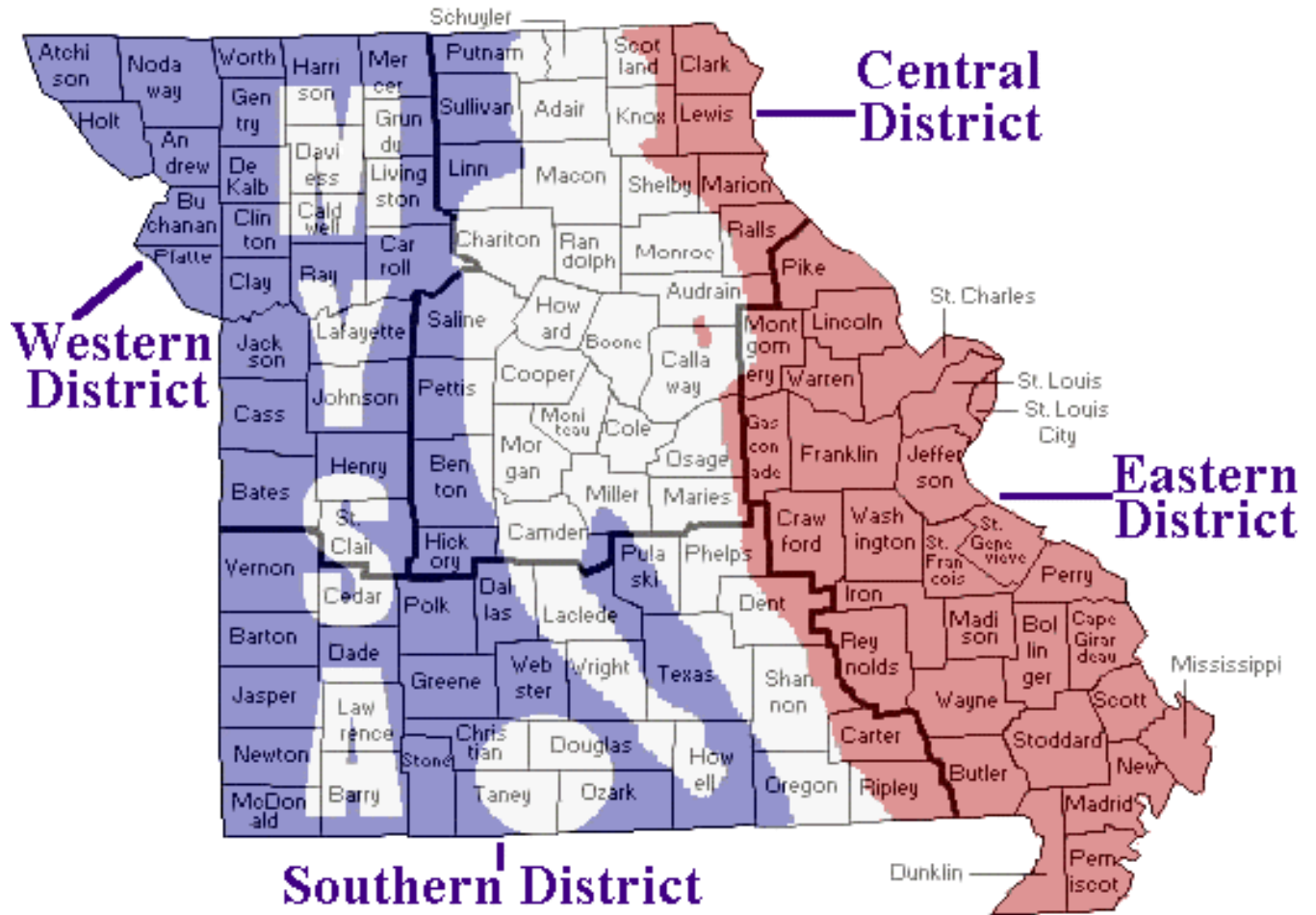
The State Office will forward copies of your Constitution, Bylaws and Rules/Policies to the Executive Committee for review.
